

ESTIMATE OF STANDARD COSTS

NEW JERSEY SURROGACY CENTER, LLC AGENCY FEE. Our free includes the following services locating and screening surrogate candidates, facilitating meetings between you and potential surrogates, coordinating with other surrogacy professionals, and providing support for both parties throughout the process.

First installment for domestic residents / international residents (due upon execution of our fee agreement)	\$10,000 / \$11,000
Second installment (due upon execution of your surrogacy contract)	\$10,000
Final installment (due upon confirmation of pregnancy by ultrasound)	\$4,600
Total agency fee	\$24,600

SURROGATE NON-MEDICAL SCREENING, PRE-MATCH TRAVEL, AND HEALTH INSURANCE EXPENSES. At the time you sign up with our agency, you will pay a one-time flat fee for your future surrogate’s non-medical screening expenses. This fee covers the cost of her criminal background check, psychological evaluation, home visit, pre-match travel expenses, and pre-match monthly premiums for her health insurance.

SURROGATE EXPENSES AND COMPENSATION. After you have been matched with a surrogate you will be asked to establish a trust account for her. You will make an initial deposit of \$4,000 to cover her expenses until the surrogacy contract is signed. At that time you will deposit the rest of the estimated amount, based on the specifics of your contract, to pay for her compensation and expenses.

ESTIMATE OF VARIABLE COSTS

In addition to the standard costs, there are a number of other costs that may be incurred during the surrogacy process. These additional costs can vary widely and are different for each individual case. The figures provided are estimates only.

COMPENSATION AND EXPENSES FOR SURROGATE BED REST. If your surrogate has medical complications and is placed on bed rest or required to reduce hour of employment, you will compensate her for lost wages, childcare, and housekeeping.	
Lost wages for bed rest (varies based on income and extent of medical complications)	Varies
Childcare (\$12-\$16 per hour; varies based on amount required beyond usual)	Varies
Housekeeping (approximately \$80 per week)	Varies

TRAVEL EXPENSES FOR SURROGATE. If your surrogate is required to travel more than 50 miles one way for screening and/or medical appointments, you will reimburse her for mileage, lodging, and meals.	
Travel expenses (ranges between \$0 and \$4,800)	Varies

OTHER EXPENSES ASSOCIATED WITH SURROGACY

NJSC may provide escrow services to pay these expenses however they are not expenses to NJSC or the surrogate.

SURROGATE INSURANCE PREMIUMS AND MEDICAL EXPENSES. You will pay for your surrogate’s uncovered pregnancy and delivery medical expenses, including premiums, deductibles, copays and prescriptions. This amount depends on medical circumstances and insurance, and does not include IVF medical expenses or newborn medical expenses incurred.	
Surrogate prenatal care and miscellaneous medical expenses (for singleton)	\$2,500
Surrogate delivery expenses (for singleton)	\$5,000
Surrogate insurance premiums	\$5,800 to \$9,800
Surrogate pregnancy and delivery medical expenses	\$13,300 to \$17,300

LIFE INSURANCE FOR SURROGATE. If your surrogate does not have life insurance or if her insurance is inadequate, you will provide a life insurance policy.	
Life insurance for surrogate (one-year term policy providing benefits in the amount of \$350,000)	\$300 to \$600
